Opening Forms

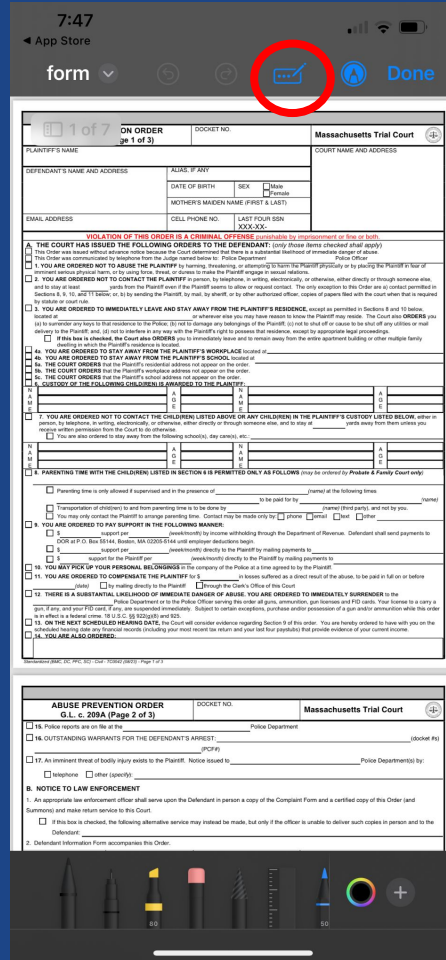
1. Search for a form in the Forms category. (eg. 209A)

Filling Out Forms

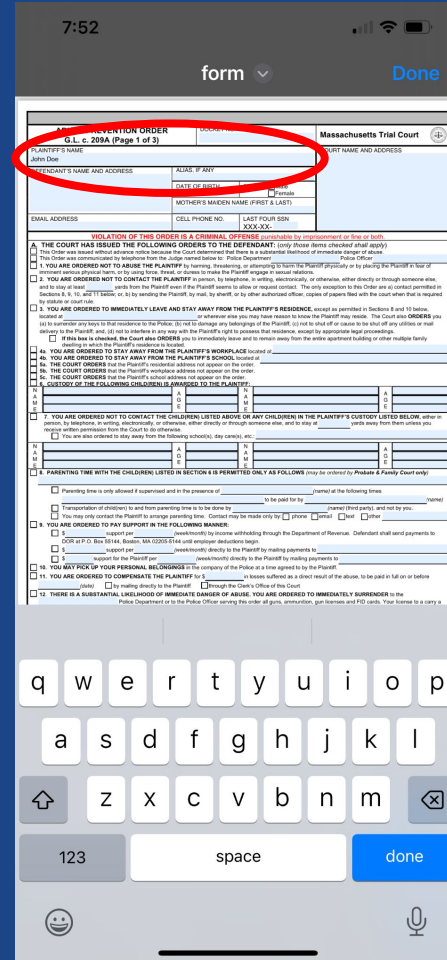
1. Tap “Markup”.

3. Fill out any fillable fields. Or double tap to create a new text field.



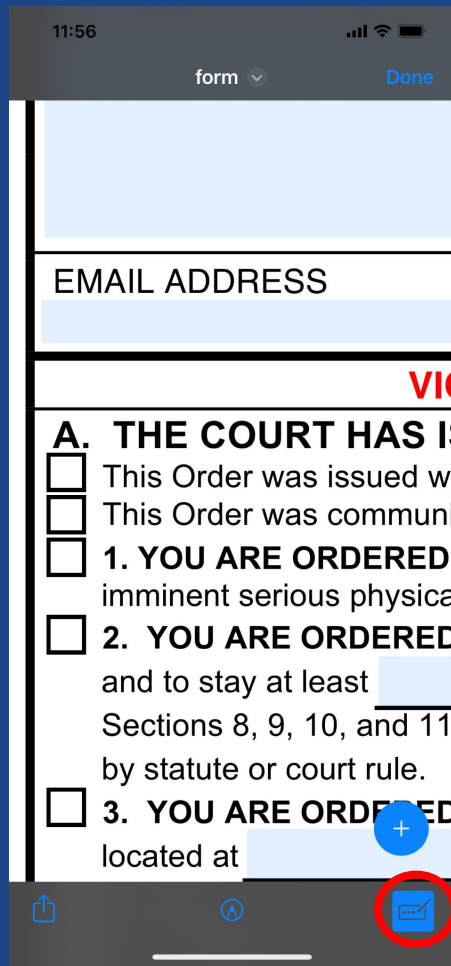

Checking Boxes

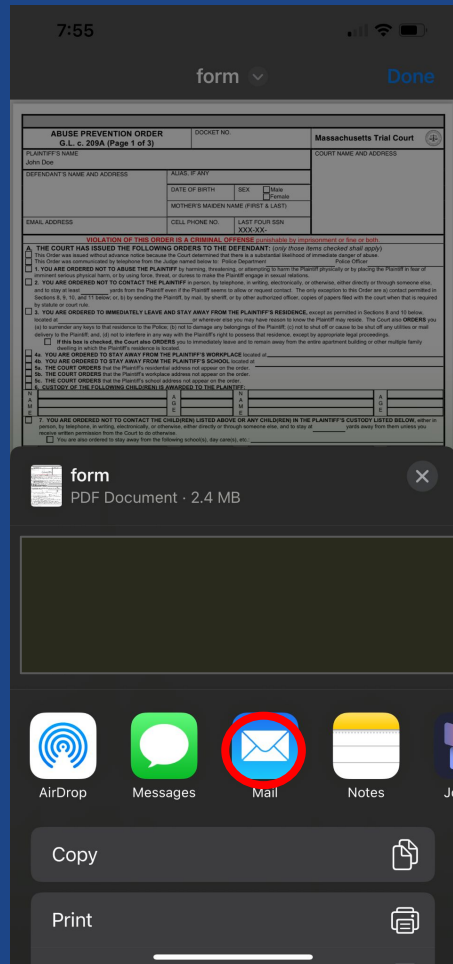
1. Tap the “Enter fields” icon again to disable it.

Sharing Forms

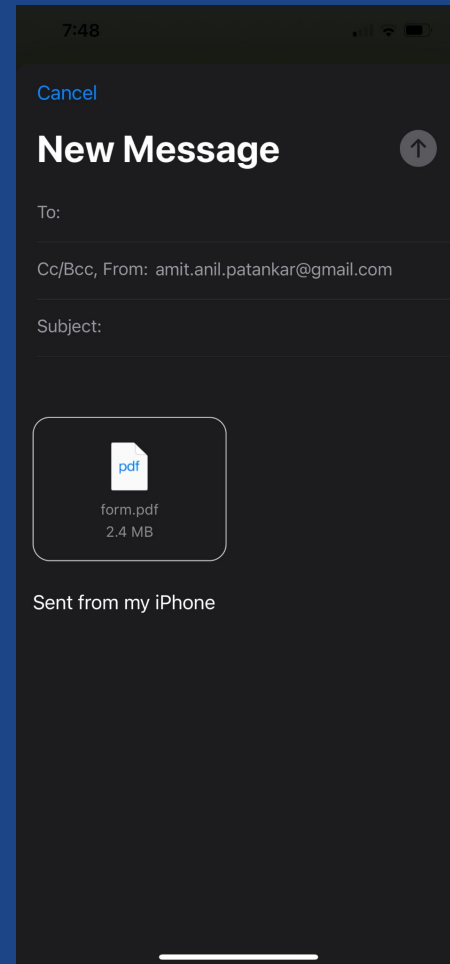
1. When finished, tap the arrow at the top and then tap the share icon.

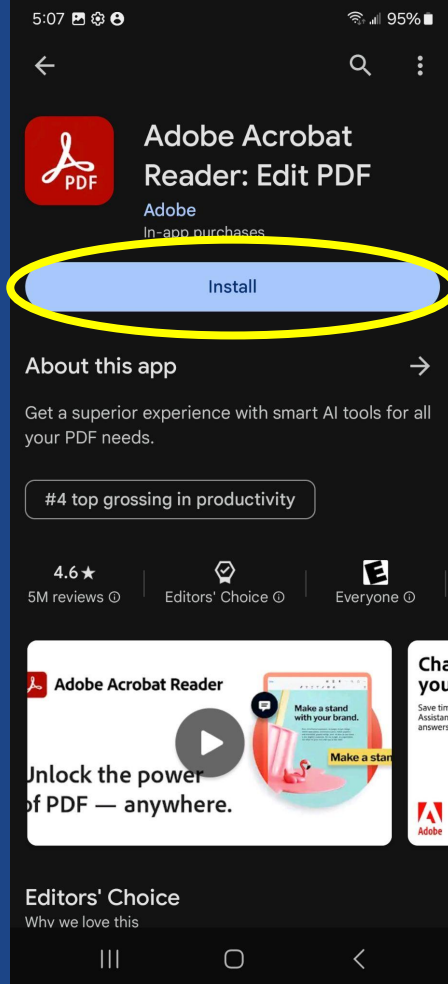
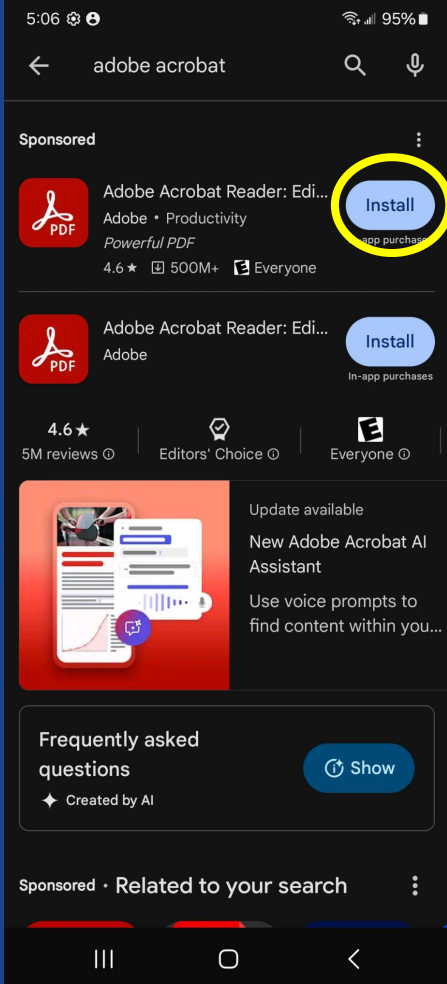

4. Please note that forms are not stored on your phone or on Blue servers and only exist in your email.



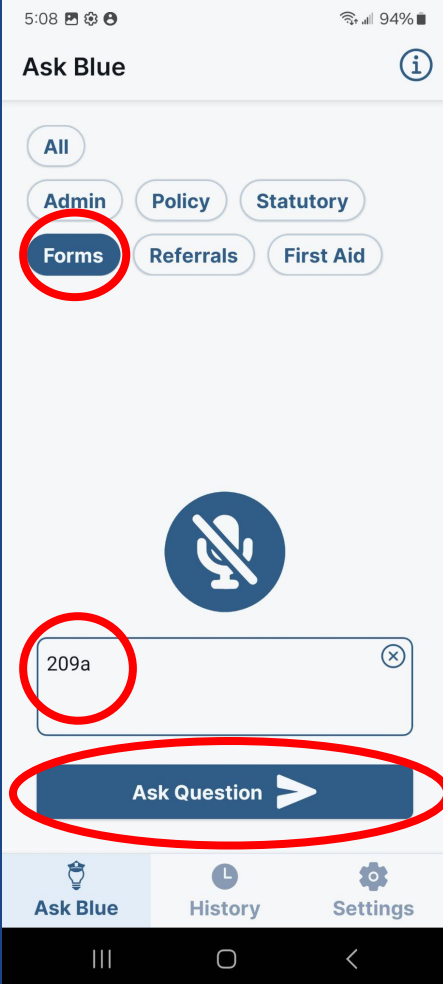

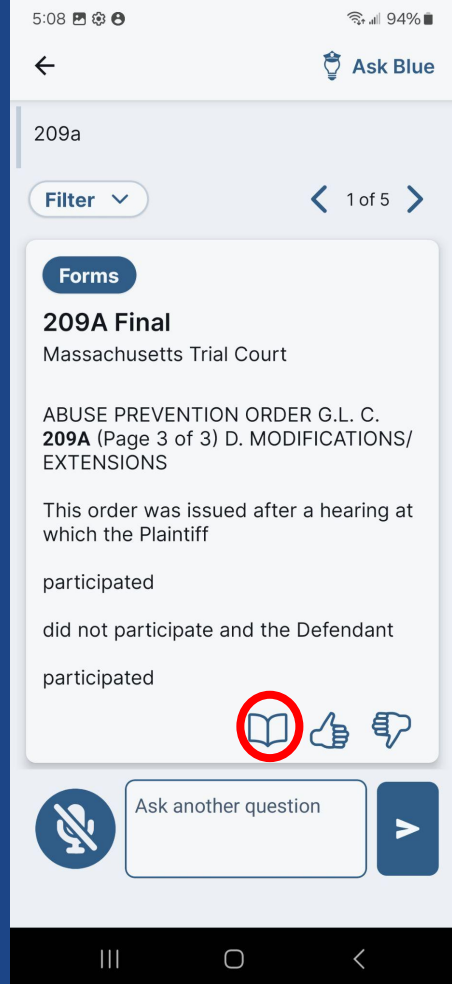
Install Adobe

2. Install the application.

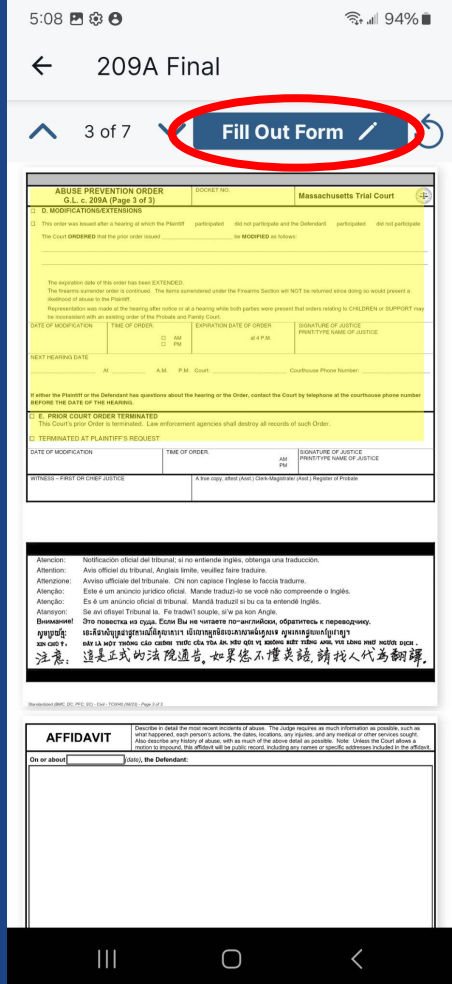

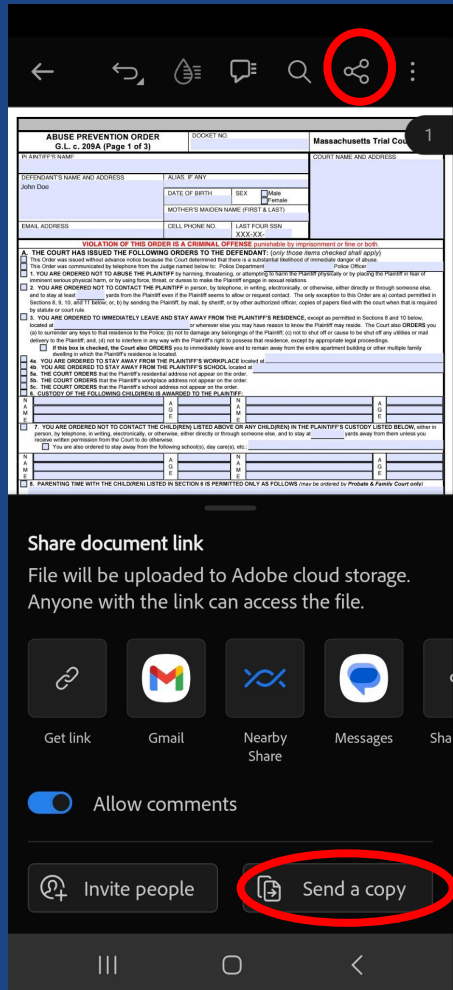
1. Tap the share icon in the top bar, and then “Send a copy”.
